**RECOMMENDING TOWN BOARD ADOPTION OF THE TOWN OF ST. JOSEPH 2016-2035
COMPREHENSIVE PLAN WHICH AMENDS AND UPDATES THE 2006 ST. JOSEPH COMPREHENSIVE PLAN**

WHEREAS, the Town of St. Joseph Plan Commission has prepared the Town of St. Joseph 2016-2035 Comprehensive Plan pursuant to §66.1001 and §62.23, Wis. Stats, which contains plan documents, maps, community survey results and other materials in the nine comprehensive plan elements required by §66.1001 (2) Wis. Stats. and

WHEREAS, The Town of St. Joseph Plan Commission pursuant to § 66.1001 (4)(b) Wis. Stats., may recommend to the Town Board the adoption of the updated comprehensive plan by adoption of a resolution to that effect by a majority of the entire Plan Commission.

NOW THEREFORE BE IT RESOLVED, the Plan Commission of the Town of St. Joseph, St. Croix County, Wisconsin, by this resolution, adopted by a majority of the Town Plan Commission on a roll call vote with a quorum present and voting and proper notice having been given, recommends to the Town Board of the Town of St. Joseph the adoption of the updated and amended Town of St. Joseph 2016-2036 Comprehensive Plan.
